## Monthly Board Meeting Minutes

- 1. Board meeting was called to order at 6:30 PM. Pledge of Allegiance was recited by all present.

- 6. Clerk's report. Discussion of ARPA monies. Town has received ½ their amount. All tavern licenses have been sent out. Shared information received in mail.
- 7. Chairman's report. Betsy shared JL Electric bill needs to be paid as it is overdue, was misplaced. Discussion of gravel delivered in township. Discussion of Squaw Point and Bailey Roads to be pulverized on same day. Sheepcamp Rd has tires that need to be picked up. Bear problem on Ranch Road, called DNR. Calls on mowing by new company, nice comments. Mike Kuch will be lowering culverts on Bailey Road. Fire # signs have been ordered. Brian reports that there are still intermittent fuel issues with the grader. Discussion for board members to leave needed passwords accessible to others if vacate their position.
- 8. Discussion of ARPA monies. Discussion of possible projects: voting machine, fire #'s, sink and wash station in shop, plexiglass guards for elections, tables and chairs, water filter system, new posting boards, ambulance assists. Discussion of qualifications for money used. Chuck made suggestion to discuss at annual meeting, it will be put on agenda.
