- 1.) Betsy Patterson called meeting to order at 6:30PM. Pledge of Allegiance was recited by all present.
- 2.) Kurt Gorsegner made a motion to approve board minutes from the previous meeting. Chuck Perry seconded. All approved and motion carried.
- 3.) Public comment. Resident reported abandoned well on property behind town hall and was inquiring as to town's liability. Discussion it was not on town's property which led to discussion of property lines of township. Chairman will request price for a survey from Morgan and Parmley. Kurt Gorsegner made the motion to approve request, seconded by Chuck Perry.
- 4.) Treasurer's report was presented.
- 5.) Clerk's report. Shared information received in the mail.
- 6.) Chairman's report. Betsy requested members bring proposals for ARPA monies to be spent by township. Discussion of recycling for township. E-mail from county regarding private roads in township. Discussion of fire # on Wilder Road driveway. Discussion of JL Electric putting up light for gas building. Discussion of resident complaint regarding land assessment: James Murray.
- 7.) Discussion/action on conditional use permit by Dennis Macklin. Request to operate a primitive campground for tenting on his land along county D. There will be a limit of 6 people per campsite with 8 campsites. Kurt Gorsegner made motion to approve the request for conditional use permit. Seconded by Chuck Perry. Mr. Macklin paid \$20.00.
- 8.) Opened gravel bids. Only one submitted from Haas. Betsy Patterson made motion to accept gravel bid, seconded by Chuck Perry. All approved and motion passed.
- 9.) Opened and discussion of mowing bid from King Clearing Co. Charge is \$63.00/hour. Chuck Perry made motion to accept bid from King. Seconded by Kurt Gorsegner. All approved and motion carried.
- 10.) Discussion of road repair of Bailey Rd. Motion made to approve pulverizing Bailey Road for \$7852.14 by Kurt Gorsegner, seconded by Chuck Perry. Approximately 190 loads for the town.
- 11.) Discussion/action on tavern and mobile home park licenses. Chuck Perry made motion to approve, seconded by Kurt Gorsegner. All approve and motion passes.


