- 1.) Betsy Patterson called meeting to order at 6:30PM. Board member, Kurt Gorsegner was absent.. Pledge of Allegiance was recited by all.

Betsy shared with him to let her know what is needed and she will get estimate and or parts.
- 7.) Presentation of application for a conditional land use permit from Bruce A Halmstad at N226 Bear Paw Rd. He is looking to have a short term rental of a cabin on his land and have local relative maintain it. Board approved, signed, and accepted fee. Clerk will send copy of minutes to Zoning.
- 8.) Mark Schmitt, District 13 Supervisor, presented recent board information. Rusk County courthouse is now open but a lot of employees are still working from home. Levy will increase slightly. New ambulance is being bought by county. New blacktop plant is \$200,000.00 over budget but will help with competitive bids. Study of zoning fees from surrounding counties and found Rusk was lower so will increase.
- 9.) Reviewed and paid invoices and bills. Motion made by Jen and seconded by Betsy. Approved and motion passed.
