- 1.) Meeting called to order at 6:30 PM. The Pledge of Allegiance was recited by all present.
- 2.) Richard Brand made a motion to approve board minutes from the previous meeting. Kurt Gorsegner seconded. All approved and motion carried.
- 3.) No Public comment. .
- 4.) Treasurer's report was presented. Peggy submitted report on her actions in regard to Mr. Repka. Next step is to send one more letter sent certified mail, then small claims if no reimbursement.

- 6.) Chairman's report. Discussion regarding home on Sawdust that was dealing with the county due to no permits. They now claim to have these and Betsy will be evaluating for a building permit. E-mail from the assessor regarding DOR and the entire township's numbers are well within the limits they should be 98.78% for residential and 87.64% for commercial, with all other at 101.78%. Problems with equipment. Mudbrook and Sheepcamp were both drifted shut and both grader and truck were stuck. County was called and able to get both out. Discussion that Plow town has does not attach to this grader. Both Jack and Steve plowed and did a great job. The lift cylinder broke on the truck, new one ordered and in meantime old was fixed so will keep new one for spare. Same person who fixed old also worked on oil leak. Everything now functioning as it should. Discussions also regarding a phone call by Brian Strzok regarding Hansen Rd not being plowed. Jack explained he could not do it without getting stuck. Discussion that all roads where town collects road tax need to be plowed. Talked about more important in case of emergency, fire truck could not get back there if fire. Possibly deed road back to owner and change it from town road.
- 7.) Presentation by Vicky Ahlers and Julie Wolf from DBar requesting a conditional use permit regarding expanding existing campground. They would like to expand the 20 permanent sites to another 50 sites within 2 years with water, sewer, and electric. They presented application and picture of proposed sites. Kurt Gorsegner made a motion to approve the application for conditional use permit and was seconded by Richard Brand. All approved, motion carried, and \$20 was paid for permit.

- 8.) Kurt Gorsegner made a motion to review and pay bills. This was seconded by Betsy Patterson. All approved and motion carried.
- 9.) Betsy Patterson made a motion to adjourn and was seconded by Kurt Gorsegner. All approved and motion carried.
